Terms and conditions for the purchase of tickets for FMX 2010 by the Filmakademie Baden-Württemberg gGmbH

General info, coverage

Our terms and conditions apply exclusively. Anyone who purchases, holds or uses a ticket shall be deemed to have agreed to the provisions of these terms and conditions.

Our Services

1. FMX Conference on Animation, Effects Games and Interactive Media is a conference on the creation, production and distribution of digital entertainment and interactive visualization in design, industry and research. The event consists of the Conference part with talks and papers, the Trade Floor for company presentations, Workshops as well as the Recruiting and Education sections with a big recruiting event, film school presentations and a platform for young talent projects and ideas.
2. The presentation of the event in the internet is not a binding offer on our part. Online ticket orders are binding. After ordering, you will receive a printable PDF.
3. After having presented registration confirmation at the entry area of FMX 2010, the visitor will receive the complete congress documents and a ticket in the form of a name badge which serves as authorized access to the event. Participation at FMX is not possible without a name badge. The ticket remains our property and is non-transferable to a third party without our express agreement.
4. The ticket entitles to participation in FMX 2010 public events (lectures, discussions, presentations, screenings and workshops) as long as the events are not already fully occupied. The seating capacities in the individual meeting areas are limited by fire regulations. A seat reservation is not possible.

Subject to change

We reserve the right to make changes in the program due to unforeseen circumstances. We cannot guarantee the appearance of advertised speakers. Programme changes or speaker changes do not entitle the visitor to cancel the contract.

Prices - Payment Terms

Our prices are in EURO (€).

House Rules

During the conference, we exercise the house rules on all event premises.

Photography, Sketching, Film and Audio Recordings

1. Professional photography, films, drawing or audio recordings requires prior permission in written form. If this is violated, we reserve the right to withdraw the entry ticket, to bar the perpetrator or to confiscate the recordings and destroy them.

Advertisement

Advertisement of any sort, in particular the distribution of advertising prints, is expressly forbidden to the visitors of FMX 2010.

Cancellation

1. If we - for whatever reason - must cancel FMX 2010, we shall refund entry tickets that have already been paid for in full. We shall refund entry tickets already paid for, less a handling charge, if the visitor cancels in written form **before 23. April 2010**. **The handling charge is € 20,00** but no more than the cost of the cheapest ticket. No refund is possible for cancellations made at a later date.

Payment of damages - Cancellation

We are entitled to withdraw from the contract regardless of the laws, if a) the client behaves contrary to the terms of the agreement and the breach of duty is substantial, b) the client gave incorrect data concerning his credit-worthiness or c) the service to be brought by us is not available. In this case, we commit ourselves to inform the client immediately about the unavailability and to refund the client immediately

Liability

We exclude an adhesion on payment of damages, going beyond it. The regulations of the product liability law remain unaffected. The organizer is only liable for bodily injury or health if such is caused by deliberate or gross negligence by the organizer or culpable injury of a substantial contract obligation by us or our executing aides. Payment of damages beyond this are excluded an adhesion on. The regulations of the product liability law remain unaffected.

Data processing

We exclusively use the personal data communicated by the visitor in accordance within the regulations of the German Data Protection Law and for the completion of the contractual relationship with the visitor. When ordering tickets, the visitor agrees to the use of his data.

Privacy

Specifications of name, city/country of residence and e-mail address will solely be used for purchase handling and are necessary for buying FMX 2010 tickets and Combitickets.

Combitickets ITFS/FMX 2010

By buying a Combiticket (valid FMX 2010 and Festival of Animated Film Stuttgart - ITFS) you agree on the disclosure of the anonymized information submitted for purchase handling to be passed on to the organizer of ITFS for billing purposes.

Place of jurisdiction - Law

1. Area of jurisdiction is Ludwigsburg.
2. The law from the Federal Republic of Germany applies.

Miscellaneous - Severability Clause

1. Oral subsidiary agreements have not been made.
2. If individual sections of this contract, a future section or section of the terms and conditions should become partly or wholly ineffective or impracticable or the effectiveness or feasibility becomes difficult or shows loopholes, then the validity of the remaining sections is not affected. The contract partners agree upon the validity of the law for this case in place of the ineffective and impracticable regulation or for filling out the loop holes.
